Annual Fee: \$1,380 payable in full at time of application or through a \$115 monthly automatic recurring payment with a PayPal subscription. \$1,380 is based on the calendar year January through December; full payment will be prorated based on the month of application submission.

## **A BPI GoldStar Contractor must:**

- Adhere to BPI's policies and procedures of the BPI GoldStar Contractor Program and to complete work in accordance with BPI Standards, where applicable
- Have at least one individual on staff with either BPI's Building Analyst, Building Analyst-Professional or Energy Auditor certification.
- Have a Customer Dispute Resolution Policy on file
- Demonstrate proof of licensing, bonding, and insurance as required by the state
- Provide BPI specific job information electronically upon request
- If required, agree to pay a standardized fee for in-field Quality Assurance inspections on per inspection basis\*
